**GLOBAL NOTES AND STATEMENT OF LIMITATIONS,
METHODOLOGY, AND DISCLAIMER REGARDING
SCHEDULES AND STATEMENTS OF DEBTORS**

The Schedules of Assets and Liabilities (the “**Schedules**”¹) and Statement of Financial Affairs (the “**Statements**” and, collectively with the Schedules, the “**Schedules and Statements**”) filed by GP Debtors 32, as debtors and debtors in possession (collectively, the “**GP Debtors-32**”)², in the above-captioned bankruptcy cases pending before the United States Bankruptcy Court for the Northern District of Texas, Fort Worth Division (the “**Bankruptcy Court**”) were prepared pursuant to 11 U.S.C. § 521 and Federal Rule of Bankruptcy Procedure 1007 by the Debtors’ to be sought to be employed financial advisor in connection with the Debtors’ personnel and/or personnel at Pinnacle Health Management, LLC (“**PHM**”), the company that provides accounting and bookkeeping services to the GP Debtors-32. The Schedules and Statements are unaudited. While the persons responsible for the preparation of the Schedules and Statements have made a reasonable effort to ensure that the Schedules and Statements are accurate and complete based on information known to them at the time of preparation after reasonable inquiries, inadvertent errors may exist, and/or the subsequent receipt of information may result in material changes in financial and other data contained in the Schedules and Statements that may warrant amendment of same. Moreover, because the Schedules and Statements contain unaudited information that is subject to further review and potential adjustment, there be can no assurance that these Schedules and Statements are complete or accurate. These Global Notes comprise an integral part of the Schedules and Statements and should be referred to and considered in connection with any review of them.

1. Cases. On July 6, 2018 (the “**Petition Date**”), the GP Debtors-32 filed voluntary petitions for relief under Chapter 11 of the Bankruptcy Code. The resulting cases (the “**Chapter 11 Cases - GP**”) were administratively consolidated into Case No. 17-44642 on or about July 23, 2018. The GP Debtors-32 are authorized to continue operating their businesses and manage their property as debtors-in-possession pursuant to §§ 1107(a) and 1108 of the Bankruptcy Code. “**Chapter 11 Cases- Pre**” shall mean the main bankruptcy case for Preferred Care Inc., Case No. 17-44642 prior to the Chapter 11 Cases-GP were filed. The resulting combined jointly administered cases (Chapter 11 Cases - GP and Chapter 11 Case-Pre) are “**Chapter 11 Cases.**”

2. Amendments. Debtors reserve their right to amend the Schedules and Statements in all respects at any time as may be necessary or appropriate, including, without limitation, the right to dispute or to assert offsets or defenses to any claim reflected on the Schedules and Statements as to amount, to liability, or to classification, or to otherwise subsequently designate any claim as “disputed,” “contingent,” or “unliquidated.” Any failure to designate a claim as “contingent,” “unliquidated,” or “disputed” does not constitute an admission by Debtors that such claim is not “contingent,” “unliquidated,” or “disputed.”

3. Estimates and Assumptions. The preparation of the Schedules and Statements requires the Debtors to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities on the date of the

Schedules and Statements, and the reported amounts of revenues and expenses during the reporting period.

4. Unknown Amounts. Some of the scheduled assets and liabilities may be unknown and unliquidated at this time. In such cases, the amounts may be listed as “Unknown” or “Unliquidated.” Accordingly, the Schedules and the Statements may not accurately reflect the aggregate amount of the Debtors’ assets and liabilities.

5. Prepetition v. Post-Petition. GP Debtors-32 have sought to allocate liabilities between the pre-petition and post-petition periods based on the information from research that was conducted with the preparation of these Schedules and Statements. As additional information becomes available and further research is conducted, the allocation of liabilities between pre-petition and post-petition periods may change.

6. GAAP. Given the difference between the information requested in the Schedules and Statements, and the financial information utilized under generally accepted accounting principles in the United States (“GAAP”), the aggregate asset values and claim amounts set forth in the Schedules and Statements do not necessarily reflect the amounts that would be set forth in a balance sheet prepared in accordance with GAAP.

7. Asset Values. The GP Debtors-32, as to their respective interest in the correlative limited partnership debtor value that partnership interest at \$0 on account of the insolvent status of the limited partnerships on their Chapter 11 petition date in the fall of 2017. To the extent an asset is listed on the Schedules and described in the Statements, unless otherwise noted therein, such assets disclosed in the Schedules and Statements were included therein as a result of the GP Debtor-32s’ books and records having reflected the existence of such assets as of the Petition Date.

8. Causes of Action. The GP Debtors-32 prophylactically reserve all of their distinct causes of action; though any such cause of action is not and cannot be the same cause of action as may be an asset of each GP Debtor-32’s correlative limited partnership debtor entity. Neither these Global Notes nor the Schedules and Statements shall be deemed a waiver of any such cause of action. Furthermore, nothing contained in the Schedules and Statements shall constitute a waiver of rights with these chapter 11 cases, equitable subordination, and/or the ability to exercise powers arising under the provisions of chapter 5 of the Bankruptcy Code and other relevant nonbankruptcy laws to recover assets or avoid transfers, to the extent same may exist.

9. Insiders. In the circumstances where the Schedules and Statements require information regarding insiders and/or officers and directors, included therein are GP Debtors 32’s (a) members, (b) the correlative limited partnership debtors for which a GP Debtor-32 serves as the general partner for, (c) family members of members, and (d) affiliates as such term is defined in the Bankruptcy Code. The listing of a party as an insider is not intended to be nor should it be construed as a legal characterization of such party as an insider and does not act as an admission of any fact, claim, right, or defense, and all such rights, claims, and defenses are hereby expressly reserved. Nothing contained in the Schedules and Statements is deemed to be an admission or legal conclusion as the comprehensive scope of the inclusion or exclusion of persons qualifying as “insiders” in terms of control of the Debtors, management responsibilities or functions, decision-making or corporate authority and/or as otherwise defined by applicable law, including, without limitation, the federal securities laws, or with respect to any theories of

liability or for any other purpose. The GP Debtors-32 reserve all rights to amend, supplement, revise the Schedules and Statements with regard to any matters concerning its “insiders,” as such term is defined in the Bankruptcy Code and their progeny. The GP Debtors-32 reserve all rights to require an order from the Bankruptcy Court regarding the scope of particular persons deemed to be “insiders.” Item 4 of the Statements requires the GP Debtors-32 to disclose payments or transfers made within 1 year before filing the bankruptcy case on debts owed to an insider or guaranteed or co-signed by an insider unless the aggregate value of all property transferred to or for the benefit of the insider is less than \$6,425.

10. Managers. The GP Debtors-32 disclosed the identity of certain officers and/or directors in Section 28 of each Statement. The Debtors’ inclusion of these persons in Section 28 of each Statement is not intended to be an admission or a legal conclusion as the status of such persons as “Managers,” or otherwise a “person in control” of a GP Debtor-32. For the sake of clarity and out of an abundance of caution, the GP Debtors-32 have included such persons in response to Section 28 of the Statement for the purpose of candid disclosure of information in these Bankruptcy Cases. The GP Debtors-32 reserve all rights to amend, supplement, revise the Schedules and Statements with regard to any matters concerning any persons deemed to be “Managers,” or otherwise a “person in control” of the GP Debtors-32, as such terms may be defined in the Bankruptcy Code and their progeny. The GP Debtors-32 reserve all rights to require an order from the Bankruptcy Court regarding the scope of particular persons deemed to be “Directors,” “Officers,” “Managers,” “Insiders,” or otherwise a “person in control” of the GP Debtors-32.

11. Summary of Reporting Policies and Practices. The following conventions were adopted by the GP Debtors-32 in preparation of the Schedules and Statements:

- a. Fair Market Value; Book Value. Unless otherwise noted therein, the Schedules and Statements reflect the carrying value of the assets/liabilities as listed in the Debtors’ books and records. Except as set forth above with respect to membership interests owned by the Debtors, where the current market value of assets is unknown, the GP Debtors-32 have based their valuation on book values; however, the actual value may differ.
- b. Disputed, Contingent and/or Unliquidated Claims. Schedules D, E, and F permit the GP Debtors-32 to designate a claim as disputed, contingent, and/or unliquidated. A failure to designate a claim on any of these Schedules and Statements as disputed, contingent, and/or unliquidated does not constitute an admission that such claim is not subject to objection. The GP Debtors-32 reserve the right to dispute, or assert offsets or defenses to, any claim reflected on these Schedules and Statements as to amount, liability, or status.
- c. Revenues. In reference to Section 1 of Part 1 in Form 207 of the Debtors’ Statements, the Debtors’ disclosure of their gross revenue includes revenue through July 6, 2018.
- d. Claims. The Schedules and Statements list creditors of the GP Debtors-32 as of the Petition Date include what are otherwise post-

petition claims, whether secured or unsecured as to same, of each GP Debtor-32's correlative limited partnership entity ("**LTD Admin Claims**"). All such LTD Admin Claims are unsecured as to the applicable GP Debtor-32. As discussed below, the Court has authorized (but not directed) the correlative limited partnership debtors to, among other things, continue certain prepetition (to those entities) practices regarding some of those claims. Under this authority, the correlative limited partnership debtors paid a number of pre-petition (to those entities) claims, including, without limitation, certain prepetition wages and employee compensation/benefits.

- e. Employee Claims. The Bankruptcy Court entered an order authorizing the correlative limited partnership debtors to pay prepetition and post-petition wages, salaries, benefits and other obligations of that entity. The correlative limited partnership debtors collectively employed approximately 2,500 employees as of the correlative limited partnership debtors petition date. Accordingly, only employee claims against the correlative limited partnership debtors GP Debtors-32 for prepetition amounts (as to that entity) that have not been paid as of the time that the Schedules and Statements were prepared, if any, and employee claims for items not authorized to be paid by order of the Bankruptcy Court, if any, have been included in the Schedules and Statements, as well as the accrued but unpaid amounts due to employees that are, as to the correlative limited partnership debtors, administrative claims of each such entity.

12. Executory Contracts and Unexpired Leases. For purposes of the Schedules and Statements, the GP Debtors-32 have only referenced scheduled claims and executory contracts for which the GP Debtors-32, as general partner of the correlative limited partnership debtor is liable as a matter of otherwise applicable state law as of the Petition Date. In the ordinary course of business, each of the correlative limited partnership debtors may have entered into agreements, written or oral, for the provision of certain services on a month-to-month or at-will basis that a respective GP Debtor-32 is liable for under otherwise applicable partnership law. Such contracts may not be included on Schedule G. But the GP Debtors-32 reserve the right to assert that such agreements constitute executory contracts.

Neither the GP Debtors-32, their agents, nor their attorneys guarantee or warrant the accuracy, the completeness, or correctness of the data that is provided herein or in the Schedules and Statements, and neither is liable for any loss or injury arising out of or caused in whole or in part by the acts, errors or omissions, whether negligent or otherwise, in procuring, compiling, collecting, interpreting, reporting, communication or delivering the information here. While every effort has been made to provide accurate and complete information herein, inadvertent errors or omissions may exist. The GP Debtors-32 and their agents, attorneys and advisors expressly do not undertake any obligation to update, modify, revise or re-categorize the information provided herein, or to notify any third party should the information be updated, modified, revised or re-categorized. In no event shall the GP Debtors-32 or their agents, attorneys and advisors be liable to any third party for any direct, indirect, incidental,

consequential or special damages (including, but not limited to, damages arising from the disallowance of a potential claim against the GP Debtors-32 or damages to business reputation, lost business or lost profits), whether foreseeable or not and however caused, even if the GP Debtors-32 or their agents, attorneys and advisors are advised of the possibility of such damages.

13. Reservation of Rights. Reasonable efforts have been made to prepare and file complete and accurate Statements and Schedules; however, inadvertent errors or omissions may exist. The GP Debtors-32 reserve all rights to (i) amend or supplement the Statements and Schedules from time to time, in all respects, as may be necessary or appropriate, including, without limitation, the right to amend the Statements and Schedules with respect to claim (“**Claim**”) description or designation; (ii) dispute or otherwise assert offsets or defenses to any Claim reflected in the Statements and Schedules as to amount, liability, priority, status or classification; (iii) subsequently designate any Claim as “disputed,” “contingent,” or “unliquidated;” or object to the extent, validity, enforceability, priority, or avoidability of any Claim. Any failure to designate a Claim in the Statements and Schedules as “disputed,” “contingent,” or “unliquidated” does not constitute an admission by the Debtors (or any individual debtor) that such Claim or amount is not “disputed,” “contingent,” or “unliquidated.” Listing a Claim does not constitute an admission of liability by the GP Debtors-32 against which the Claim is listed. Furthermore, nothing contained in the Statements and Schedules shall constitute a waiver of rights with respect to each GP Debtor 32’s chapter 11 case, including, without limitation, issues involving Claims, substantive consolidation, defenses, equitable subordination, and/or the use of powers arising under the provisions of chapter 5 of the Bankruptcy Code and any other relevant non-bankruptcy laws to recover assets or avoid transfers. Any specific reservation of rights contained elsewhere in the Global Notes does not limit in any respect the general reservation of rights contained in this paragraph. Notwithstanding the foregoing, the GP Debtors-32 shall not be required to update the Statements and Schedules except as may be required by applicable law.

14. Liabilities. The Debtors have sought to allocate liabilities based on the information and research conducted in connection with the preparation of the Statements and Schedules and consulting the Statements and Schedules of each GP Debtor-32’s correlative limited partnership entity, as well as reviewing latest filed MORs and to be filed MOR to ascertain levels of LTD Admin Claims just prior to filing. As additional information becomes available and further research is conducted, the allocation of liabilities between the prepetition and post-petition periods may change. Accordingly, each of the GP Debtors-32 reserve all of their rights to amend, supplement, or otherwise modify its Statements and Schedules as is necessary or appropriate.

The liabilities listed on the Schedules do not reflect any analysis of Claims under section 503(b)(9) of the Bankruptcy Code. Accordingly, the GP Debtors-32 reserve all of their rights to dispute or challenge the validity of any asserted Claims under section 503(b)(9) of the Bankruptcy Code or the characterization of the structure of any such transaction or any document or instrument related to any creditor’s Claim.

15. Intercompany Payables and Receivables. Intercompany payables are set forth on Schedule E/F of the correlative limited partnership debtors and to the extent such intercompany payable survive, it is presumed that the applicable GP-Debtor-32 is also liable for that sum (net of Intercompany Receivables that are mutual, would be allowed as a Claim, an Interest, or not

allowed at all. The GP Debtors-32 and all parties in interest reserve all rights with respect to such accounts.

16. Employee Addresses. Pursuant to the *Order Granting Motion for Entry of An Order (I) Authorizing the Filing of a Consolidated List of Creditors and a Consolidated List of the 30 Largest Unsecured Creditors, (II) Authorizing the Debtors to Redact Certain Personal Information for Individual Creditors, and (III) Approving the Proposed Form of Proof of Claim in these Cases* [Docket No. 62], current employee addresses have been redacted from the GP Debtors-32's Schedules and Statements where applicable.

17. Debtors' Addresses. For the purposes of the Statements and Schedules, all addresses for all Debtors have been reported as the Debtors' headquarters address in Plano, Texas.

**Specific Notes Regarding Debtors' Schedules of Assets
and Liabilities and Debtors' Statement of Financial Affairs**

Neither the Schedules nor the Statement of Financial Affairs purport to represent financial statements or other reports prepared in accordance with GAAP, nor are they intended to be fully reconciled with the financial statements of the GP Debtors-32. Additionally, the Schedules contain unaudited information that is subject to further review and potential adjustment and reflect the GP Debtors-32's reasonable best efforts to report the assets and liabilities of each GP Debtor-32. Moreover, given, among other things, questions about the characterization of certain assets and the valuation and nature of certain liabilities, to the extent that any GP Debtor-32 shows more assets than liabilities, this is not an admission that such Debtor was solvent as of the Petition Date or at any time before the Petition Date. Likewise, to the extent any Debtor shows more liabilities than assets, this is not an admission that such GP Debtor-32 was insolvent as of the Petition Date or at any time before the Petition Date.

Statement of Financial Affairs:

Part 3, Question 7 of the Statements requires that the GP Debtors-32 list "legal actions, proceedings, investigations, arbitrations, mediations, and audits by federal or state agencies in which the debtor was involved in any capacity—within 1 year before filing this case." To the best of their knowledge, the GP Debtors-32 have disclosed all pending legal actions except for those legal actions or investigations where a GP Debtor-32 is precluded by court order, if any. That includes litigation filed in which the GP Debtors-32 have been named as a party to the litigation *or* appear as a "d/b/a" in the style or heading of the case. Inclusion of such cases should not be construed as an admission that the applicable GP Debtor-32 is actually a party to the case, actually does business as the name listed, or should be included in the case as listed. The GP Debtors-32 reserve all rights in connection with each listed lawsuit, including, but not limited to, the right to dispute or challenge whether they (or any one of them) are/is actually a party in each listed lawsuit.

Schedules:

Schedule E/F: Each GP Debtor-32 lists the same parties listed on the correlative limited partnership's Schedule E/F. Each GP Debtor-32, has a Schedule F claim operational accounts payable from its correlative limited partnership debtor entity as of July 6, 2018. Nevertheless, such claims are not listed as those claims are currently being paid as they come due in the ordinary course of the correlative limited partnership debtor entity and should shortly no longer be unpaid unsecured claims of the applicable GP-Debtor-32. Additionally, listings of executory contracts or unexpired leases listed by a correlative limited partnership debtor entity in its Schedule G have the potential to generate a Schedule F claim against the correlative GP Debtor-32 if the executory contract or unexpired lease is rejected and generates an unsecured claim, but such contingent prospective claims are not listed as they are too speculative to justify the effort. Claims of any DIP lender to correlative limited partnership debtor entity are allocated as those liabilities are to each such entity, (post-petition and are either newly added as a Schedule F claim or such amounts are added/reduced, net of activity authorized in that specific case, to the pre-petition amount owed by the correlative limited partnership debtor entity

Schedule H: Not listed as a Co-Debtor in a GP Debtor-32, is the correlative limited partnership debtor entity who is also liable for the claims scheduled in the Chapter 11 Cases-Pre, that are otherwise also scheduled in the Chapter 11 Cases -GP, if such creditor is not otherwise listed in Schedule H. Additionally, FSF DIP, LLC's listing in Schedule F of a GP Debtor-32 also is a debt which all of the other GP Debtors-32 are jointly and severally liable upon and thus are Co-Debtors of each other.


